Notice is given that National Highways Limited (a), Herefordshire Council and Gloucestershire County Council propose to make Orders under section 84(1)(a) and (2) of, the Road Traffic Regulation Act 1984 on part of the A40 Trunk Road and side roads in Gloucestershire and Herefordshire.

The effect of the Orders would be to impose a 40 mph speed limit on:


- (a) the A40 eastbound and westbound between 9 metres east of the junction with the entrance to Huntley Industrial Estate and 92 metres southeast of the junction with The Oaks.
- (b) Barrel Lane from 205 metres northeast of the A40 to its junction with the A40.
