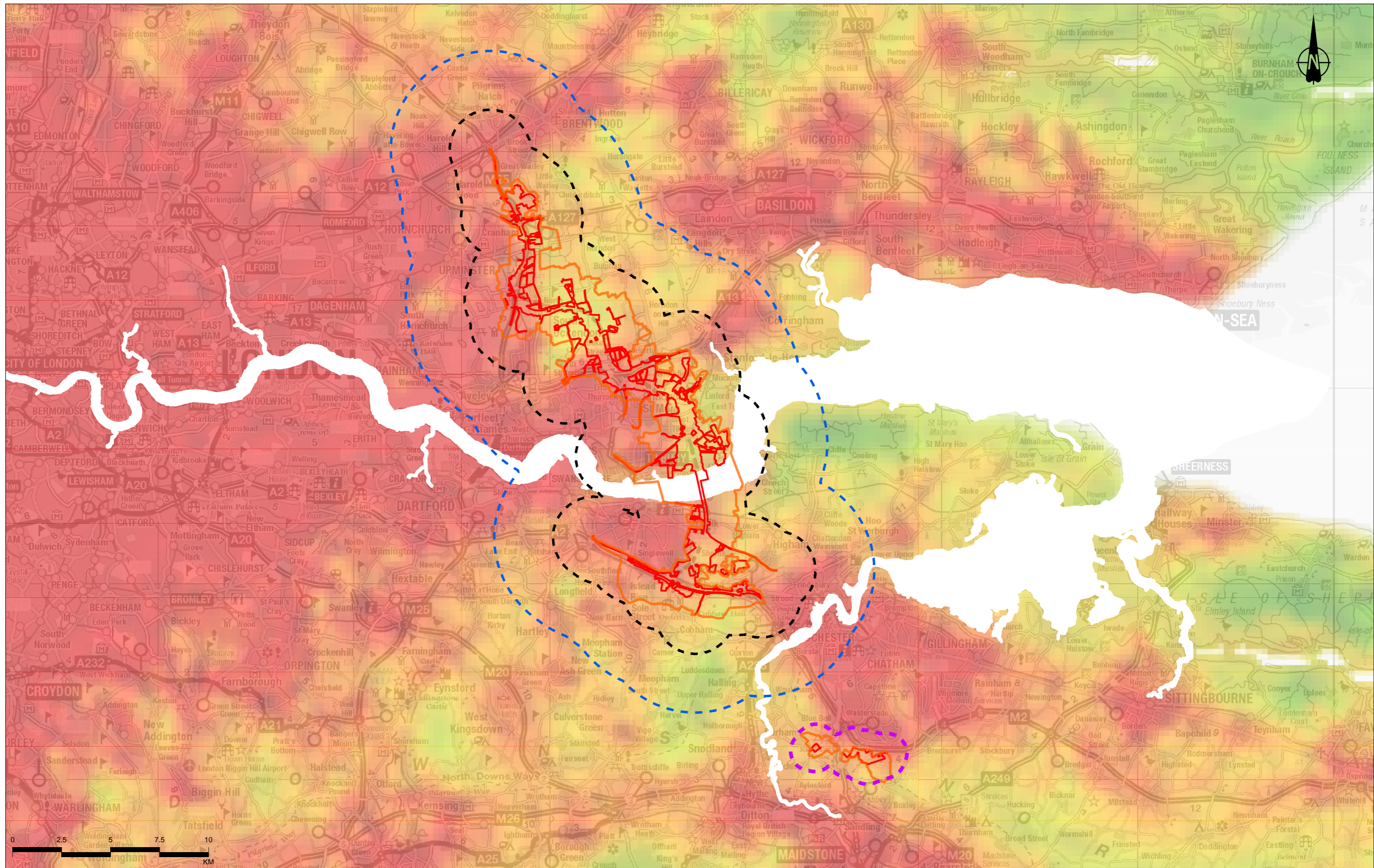
Figure 7.5 - Tranquillity Campaign to Protect Rural England

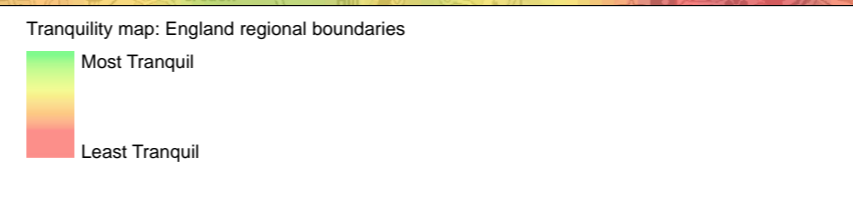
