Consultation on a draft Statutory Instrument to introduce an exemption from the offside lane use restriction on the M621 motorway westbound.

Summary of the consultation

Topic of this consultation	Exemption from the offside lane use restriction on the M621 motorway westbound.
Scope of this consultation	We are keen to have your comments on the implementation of an exemption from offside lane use restriction for the westbound M621 motorway scheme between junctions 1 and 7. We specifically would like to hear how the proposal could affect you, your organisation or those you represent. We are seeking your views on the proposal set out within this document.
Geographical scope	This motorway scheme will enable proactive management of the M621 carriageway, between junctions 1 and 7 on this major section of motorway.

Executive Summary

This consultation provides an opportunity for interested parties to comment on the proposal to introduce, by way of a Statutory Instrument, new Regulations which provide an exemption from offside lane use restriction westbound for the M621 Junctions 1 to 7 motorway scheme.

Once in force, the Regulations will lift the restriction on use of the right hand or offside lane to any vehicle using the specified length of westbound carriageway and allow for the closure of junction 2A westbound exit slip road.

Benefits of westbound exemption from offside lane use restriction

• This change is to lift the restriction on the use of right hand or offside lane to any vehicle using the specified length of the westbound carriageway is to help facilitate the closure of junction 2A westbound exit slip road and allow for safe merging of all vehicles at junctions 3 and 2.

We welcome comments specifically on how the proposal could affect you, your organisation or those you represent.

1. How we are conducting the consultation

1.1. What is this consultation about?

We are consulting on the proposed implementation of a westbound exemption from offside lane use restriction within the M621 Junctions 1 to 7 scheme.

1.2. Why do we need the exemption from offside lane use restriction?

We will be changing Junction 3 westbound to give priority to the main M621 traffic and reducing the on-slip to one lane, creating a junction where traffic merges from the on-slip road on the right-hand side of the carriageway. To help facilitate this merge we need to provide an exemption from offside lane use restriction. This means that any vehicle (including heavy goods vehicles) can make use of right hand or offside lane using the length of the scheme Westbound.

There is an existing exemption from offside lane use restriction in place between junctions 6 and 3. This restriction is to be retained but the precise extents will be amended.

We are adding a third lane on the M621 westbound between junctions 2 and 1 and the exemption from offside lane use restriction will also apply over this section.

The scheme is part of the National Highways' programme to add capacity to the existing strategic road network to support economic growth and maintain mobility. It is expected that the motorway scheme will:

- Increase motorway capacity and reduce congestion
- Smooth traffic flows
- Provide more reliable journey times
- Increase and improve the quality of information for the driver (in relation to the operation of the motorway)

The use of the exemption from offside lane use restriction is required to achieve the objectives above on this part of the M621. Through the changes made by the scheme, we aim to make best use of the existing road space.

2. Legislative changes

2.1. Legislative changes for the implementation of exemption from offside lane use restriction

Subject to the outcome of this consultation, Regulations will be made under sections 17(2) and (3) of the Road Traffic Regulation Act 1984 (RTRA 1984), which will make an exemption from offside lane use restriction for the M621 Junctions 1 to 7 scheme. Sections 17(2) and (3) of RTRA 1984 permit the making of Regulations (by way of a Statutory Instrument) that regulate the manner in which, and the conditions subject to which, motorways may be used by traffic authorised to use such motorways.

The proposed Regulations will disapply regulation 12 of the Motorways Traffic (England and Wales) Regulations 1982 (which prohibits certain vehicles from using the right hand or offside lane of a motorway carriageway with 3 or more lanes) in relation to the length of westbound carriageway of the M621 Motorway specified in the draft Statutory Instrument.

The Regulations will also revoke the Motorways Traffic M621 (Motorways) Regulations 1999 in their entirety.

An impact assessment has not been prepared for the proposed Regulations as no significant impact on the cost of business or the voluntary sector is foreseen. An Explanatory Memorandum will be published alongside the Regulations at <u>www.legislation.gov.uk</u> in due course.

Subject to the outcome of the consultation, the Regulations when made will apply in relation to the M621 between junctions 1 and 7 westbound.

These Regulations would put in place the legislative framework required to operate exemption from offside lane use restriction within the scheme.

This consultation is solely about the use of the exemption from offside lane use restriction that are proposed for this motorway scheme. The key features of the motorway scheme are described in section 3.2.

3. General information on the M621 Junctions 1 to 7 scheme

3.1. Proposed extent of the M621 junctions 1 to 7 scheme exemption from offside lane use restriction

The M621 runs from junction 27 of the M621 to junction 43 of the M1 and serves the centre of Leeds and surrounding areas. The M621 Junctions 1 to 7 Improvement Scheme includes technology upgrades to the full M621 corridor, but with the majority of improvements taking place between junctions 1 and 4.

A map showing the scheme extent can be found in **Appendix D**.

Explanation of changes affected by exemption

J3 to J2 westbound

As a result of the works by the M621 improvement scheme vehicles merging onto the mainline M621 at J3 will be doing so in a single lane, and that lane will become lane three of the three lane motorway (i.e. the right hand or off side lane) between J3 and J2.

As traffic will be proceeding in the same direction from J3 to J2 westbound, and there are three lanes, in the interests of safety it's considered to be beneficial for any type of vehicles that would normally be restricted (e.g. heavy goods vehicles, vehicle drawing a trailer or high occupancy vehicle) to remain in lane 3 through this weaving section should they wish to do so as otherwise it would increase lane changing.

J2 to J1 westbound

Between J2 and J1 westbound any formerly restricted vehicles who have been in Lane 2 within Junction 2 area would be required to move into the middle lane for a short distance within a weaving section.

Implementation of these proposed regulations would allow any vehicles to remain in the same lane throughout this section, rather than being faced with a situation where they are allowed in lane 2 through junction 2, not allowed in lane 3 between junctions 2 and 1, and then allowed in lane 2 through junction 1. It would be beneficial for vehicles to remain in lane 3 through this weaving section should they wish to do so as otherwise it would increase lane changing.

Summary

The combined effect of the proposed regulations will allow any type of vehicles to remain in the same lane throughout this section of the M621 and will allow the offside merge at Junction 3 to function effectively.

3.2. Key Features

The design features of the scheme include:

- The introduction of a free-flowing connection between the M621 eastbound and the A643 northbound at junction 2;
- Adding an additional lane to the roundabout at junction 2;
- Adding a third lane between junction 2 and 1 westbound;
- Providing two lanes on the main M621 through junction 3 westbound , instead of one lane at present;
- Changing junction 3 westbound to give priority to the main M621 traffic and reducing the on-slip to one lane, creating a junction where traffic merges from the on-slip road on the right-hand side of the carriageway;
- Adding a third lane between junctions 2 and 3 westbound by converting the existing hard shoulder and auxiliary lanes;
- Closure of junction 2A westbound to enable the improvements at junction 3;
- Adding traffic lights to the junction between Cemetery Road and Elland Road.
- Adding a crossing at the end of Elland Road where it joins Cemetery Road.
- Providing improved motorway technology along the M621 corridor.

Appendix A: Frequently asked questions

Q. What is happening on the scheme?

- **A.** The M621 motorway is a strategic route for local, regional and international traffic and aims to ;
 - Provide a safe and serviceable network
 - Provide a more free-flowing network
 - Improve the environment
 - Provide an accessible integrated network
 - Support economic growth

The project is proposing to give priority to the main M621 traffic at junction 3 westbound and reducing the on-slip to one lane. To help facilitate this an exemption will be granted to lift the restriction on the use of the right hand or offside lane to any vehicle using the specified length of the westbound carriageway to allow for safe merging of all vehicles.

Q. HOW WILL THIS IMPROVE TRAFFIC FLOW?

A. The M621 improvement scheme is designed to provide drivers with a more free-flowing motorway which will in turn reduce their journey times. The addition of additional lanes at key strategic points, the change in priority for M621 traffic, and the introduction of technology will contribute towards keeping traffic moving at a safe and efficient rate.

Currently the M621 westbound is reduced from two lanes to one at junction 3. The scheme will remove this existing bottle neck by maintaining two lanes at this point. Additional capacity will be added between junction 2a and junction 2 by creating a short length of discontinuous hard shoulder, and junction 2 roundabout will be widened from two to three lanes to the north of the roundabout and two to four lanes to the south. These improvements, alongside improved driver information, will help to improve traffic flow.

Q. Why is National Highways consulting?

A. This consultation will provide an opportunity for interested parties and individuals to comment on the legislative changes required to allow for the implementation of the exemption from offside lane use restriction within a motorways scheme on this section of the M621.

Q. Who can respond to this?

A. This consultation is available for anyone to respond to, including organisations that would be affected by the implementation of the exemption from offside lane use restriction. The consultation is aimed at any affected stakeholder groups.

Q. What is the point of the consultation?

A. National Highways is committed to effective consultation and complies with the Government's Consultation Principles. Effective consultation with affected stakeholders brings to light valuable information which we are able to use to design effective solutions and mitigate any concerns.

Following the consultation period, responses will be issued where appropriate, and a summary report compiled which will provide an analysis of the responses and provide justification for the selected option.
